

# Implementation Of New Quality Management Standards By Smps

#### INTRODUCTION

While the effective date (15 December 2022) for the IAASB's new and revised <u>suite of quality management (QM) standards</u> has come and gone, it is by no means too late to start implementing them. The new standards raise the bar on quality management by strengthening and modernizing how a firm of any size or level of complexity approaches quality management. In so doing they present significant benefits but also challenges, not least that of implementation. While designed to be scalable, implementation is especially challenging for small- and medium-sized accountancy practices (SMPs).

The IAASB has released a new <u>edition of the Handbook of International Quality Control, Auditing, Review, Other Assurance, and Related Services Pronouncements, which includes the new and revised suite of quality management standards. Read more here.</u>

Fortunately, there is a large and growing amount of guidance and support available to SMPs and their professional accountancy organisations (PAOs). IFAC plans to provide further support this year.

This article shares the approach of one SMP in the journey to implement the new QM standards as well as list some of the electronic implementation tools available that might help SMPs.

## CASE STUDY: ONE SMP'S APPROACH TO IMPLEMENTATION

George Josephakis is the managing partner of an SMP that was founded in 1996 and is based in Cyprus. The firm offers a range of professional services. The firm implemented the new QM standards in stages as shown in the table below. The firm also tested some electronic tools from commercial suppliers but ultimately decided to create its own QM manual and tools.



#### STAGES OF ISQM IMPLEMENTATION

## 1. Internal Meeting of Audit Staff (March 2022)

- a. Distribute electronic copy of new standards
- b. Discuss, analyze, and understand scope, objective, and requirements of new standards
- c. Identify, discuss, and understand changes from ISQC 1 (extant standard)
- d. Arrange external training (see 2. below)
- e. Appoint team to design firm's ISQM manual
- f. Set implementation target date.

#### External Training (March – September 2022)

Two sessions conducted by ICPAC and two sessions by PCP Ltd.

#### 3. Purchase and Study ISQM manuals from Two UK Specialist Firms (13/04/2022)

### 4. Design Firm's ISQM Manual (29/07/2022)
