EFAA for SMEs considers that digitalization can often be promoted by the introduction of legal requirements. However, the introduction of an obligation of elnvoicing for B2G only was probably cumbersome for SMEs and introduced complications for micro and small undertakings as it obliged SMEs wanting to participate in public procurement to establish an ad hoc invoicing system. This is an unjustified burden for SMEs.

5. Future needs of elnvoicing in Europe

In your view, what are the current and future needs of elnvoicing? (e.g., including technical solutions, transmission level, and the scope of covered transactions)

Consider explaining the potential need for changes in the context of elnvoicing and the respective ways to address those.

EFAA for SMEs suggests the incentivisation and support of the use of elnvoicing by SMEs but also to making elnvoicing as broad as possible. elnvoicing should become the usual invoicing tool.

EFAA for SMEs considers that any elnvoicing issuing procedure should be as simple as possible and as easy to use as paper invoicing. Once an undertaking implements elnvoicing it should not be requested to issue also paper invoices.

The recording of transactions should be as simple and logical as possible for both the issuer and the receiver of the e-invoice.
